

Non-Disclosure Agreement

(the **Recipient**)

1. Purpose

The Discloser intends to share certain confidential information with the Recipient for the purpose of discussing a potential business relationship, including the possibility of appointing the Recipient as the Discloser's manufacturer (the **Purpose**).

2. Definition of Confidential Information

"**Confidential Information**" means all information disclosed by the Discloser to the Recipient, whether oral, written, visual, or electronic, that is identified as confidential or should reasonably be understood to be confidential. This includes, without limitation, product designs, pricing, branding, technical data, customer lists, business strategies, and other proprietary materials.

3. Confidentiality Obligations

The Recipient agrees:

- Not to use the Confidential Information for any purpose other than the Purpose;
- Not to disclose it to any third party, except to employees or professional advisors who have a need to know for the Purpose and are bound by similar confidentiality obligations;
- To keep all Confidential Information secure and protected from unauthorized access.

4. Exclusions

The obligations in this Agreement do not apply to information that:

- a) Is or becomes publicly known through no fault of the Recipient;
- b) Was already in the Recipient's possession without any obligation of confidentiality;
- c) Is disclosed to the Recipient by a third party legally entitled to do so; or
- d) Must be disclosed by Law or regulation, provided the Recipient gives prior notice to the Discloser (where legally permitted).

5. No Obligation to Proceed

Nothing in this Agreement requires either party to proceed with any business arrangement or relationship.

6. No License

No rights or licenses are granted by the Discloser to the Recipient under any patents, copyrights, trademarks, or other intellectual property, except as strictly necessary to evaluate the Confidential Information for the Purpose.

7. Return of Information

Upon written request, the Recipient will promptly return or destroy all documents, data, and materials containing Confidential Information and confirm in writing that it has done so, **at the Discloser's cost**.

8. Duration

The confidentiality obligations in this Agreement will remain in force indefinitely from the date of this Agreement.

9. Limitation of Liability

Neither party shall be liable for any indirect or consequential loss arising out of this Agreement.

10. No Partnership

Nothing in this Agreement creates a partnership, joint venture, or agency relationship between the parties.

11. Governing Law and Jurisdiction

This Agreement is governed by and shall be interpreted in accordance with Indonesian Law. The courts of Indonesia shall have non-exclusive jurisdiction over any disputes arising from this Agreement.
